# **Needle Exchange Programme – Why?**

- □ To keep people safe from harms associated with injecting drug use
- Hepatitis C identification, testing and treatment
- □ HIV infection rates among PWID remain the lowest in the world
- It is one of the most effective public health programmes in New Zealand in terms of health outcomes and cost benefit
- For every \$1 spent NZ saves \$6.79 in downstream health related costs (HCV HIV etc)



# Who provides the service

#### **20 Dedicated needle exchanges + Mobile Services**

- Main centres
- A peer-based service

#### 200 Pharmacies

Good coverage across Aotearoa New Zealand

#### Alternate Outlets

- New Zealand Prostitutes Collective
- Sexual Health Clinics
- Community Health Providers
- Hospital Pharmacies



# Confidentiality

- □ The programme is entirely confidential
- □ No records of names or other identifying details are kept
- I You may NOT disclose to any third party any details of clients using the service
- Confidentiality covers clients on the Opioid Substitution Treatment Programme
- □ Extend the same discretion given to any other customer
- □ Needle exchange clients use the service at your pharmacy based on trust.



#### Stigma

- □ Stigma is a negative attitude or belief about a mental, physical or social feature of a person or group of people
- Stigma is one of the biggest issues faced by the people that use the service. They consistently suffer discrimination which then negatively impacts their health and wellbeing
- Many of the people that use the NEP services have or have had major trauma in their lives
- □ Often people will self stigmatise "I'm bad for what I do"
- Providing non judgemental support to people using the service, improves their health and wellbeing
- □ Reducing stigma is a major goal within the needle exchange programme.



# **Distributing Equipment**

- A double arrow symbol identifies being part of the Needle exchange programme (NEP)
- □ The NEP provides free equipment to clients
- □ Six pre-made packs available to distribute to clients
- Packs are colour coded for easy identification while being discreet
- □ Meets most drug use needs
- Always encourage used equipment to be returned but is not a requirement.

#### Packs for Clients



#### Six packs available free to clients

- □ Standard IV Pack
- □ Intramuscular PIEDs Pack
- □ 1ml Fixed Needle Pack
- □ 10ml Syringe Pack
- □ All in One Pack
- Butterfly Pack



#### **Standard IV Pack**

- ✓ 10 x 3ml syringe
- ✓ 10 x 27g x ½ needles
- ✓ 10 x alcohol prep pads
- ✓ 1 x personal sharps container
- ✓ 1 x information leaflet

This is a basic multi-purpose pack for people who use a wide range of drugs.



## **Intramuscular PIEDs pack**

- ✓ 10 x 3ml syringe
- ✓ 10 x 23g x 1 ½ needles
- ✓ 10 x 18g x 1 ½ needles
- ✓ 10 x alcohol prep pads
- ✓ 1 x personal sharps container
- ✓ 1 x information leaflet

This is primarily aimed at people who use Performance and Image Enhancing Drug (PIEDs) but is suitable for anyone who in injecting intramuscularly as there is a drawing up needle along with a longer larger gauge needle for injecting directly into the muscle.



# **1ml Fixed Needle pack**

- ✓ 10 x 1ml Insulin syringes with attached 29g needle
- ✓ 10 x alcohol prep pads
- ✓ 1 x personal sharps container
- ✓ 1 x information leaflet

This pack is tailored to methamphetamine and subcutaneous Performance and Image Enhancing Drugs (PIEDs)use.



# **10ml Syringe pack**

- ✓ 5 x 10ml syringes
- ✓ 5 x 27g x ½ needles
- ✓ 5 x alcohol prep pads
- ✓ 1 x personal sharps container
- ✓ 1 x information leaflet

This pack is suitable for use by people who inject Methadone or Methylphenidate and do not require use of a butterfly to inject.



# All in One pack

- ✓ 2 x 3ml syringe
- ✓ 2 x 27g x ½ needles
- ✓ 2 x alcohol prep pads
- ✓ 1 x personal sharps container
- ✓ 1 x sterile water
- 1 x maxicup
- ✓ 1 x information leaflet

This pack covers a range of drug use and is suitable for morphine, methamphetamine, and smaller amounts of methylphenidate or methadone.



# **Butterfly pack**

- ✓ 2 x 10ml syringe
- ✓ 2 x 18g x ½ blunt needles
- ✓ 2 x 25g butterflies
- ✓ 2 x alcohol prep pads
- ✓ 1 x personal sharps container
- ✓ 1 x information leaflet

This pack is for opioid/methadone clients or people injecting larger amounts of Methylphenidate with long injecting careers and difficult/fragile veins.



#### **Other products**

Additional equipment which are not in the packs includes:

- ✓ 26g needles
- ✓ Sterile water
- ✓ Tourniquets
- ✓ Return containers

For needle exchange programme clients only.



# Sharps Bin

- □ Sharps bins are supplied by Interwaste
- □ These are for NEP waste only
- □ A wall bracket is available on request
- □ Never handle used equipment
- □ Clients should be directed to the sharps bin to dispose of their own container.



#### Rebate

- □ Claim a rebate of \$2.00 + GST for each pack given to clients free
- □ \$0.20 for other needles
- □ Claim on a monthly basis via invoice
- □ Send to <u>rebate@nznep.org.nz</u>
- □ Paid 20th month following invoice.
